The candidates should bring the following original certificates: -

1. 1. All original Educational Certificates (from SSLC onwards), the Latest Caste Certificates for SC/ST/OBC (Non-Creamy Layer) issued by a Competent Authority, and Experience Certificates have to be produced, failing which they will not be allowed to appear for interview.
2. They are also required to submit a clear experience certificate for research after obtaining the requisite educational qualification to the effect that the same will be treated as research experience for the post.
3. Request for Change of Interview Date and Skype interview will not be entertained.
4. No TA/DA will be paid for attending the interview.
5. 5. An MCQ-based written test will be conducted for all the candidates. Based on the marks obtained, 5 candidates will be shortlisted for the interview.
