In reference to notice no. AIIMS/NGP/ADMIN/RECT/NORCET/08/903 date: 02.07.2025 issued by AIIMS Nagpur regarding eligibility status of candidates after completion of document verification for the post of Nursing Officer through NORCET-08 at AIIMS Nagpur.

2. As per the above notice, ‘Partially Eligible’ candidates were given an opportunity to submit documents as mentioned against their name in support of their eligibility by email to nonfac.recruitment@aiimsnagpur.edu.in latest by 10.07.2025, 5.00 P.M.

3. Based on the documents (claim/objection) submitted by the candidates in support of their eligibility and same were verified by the scrutiny committee. After examination of documents, the final eligibility status has been prepared and is enclosed as **ANNEXURE-A**.

4. Offer of appointment will be issued shortly to all ‘Eligible’ candidates, mentioned in the **ANNEXURE-A** of this notice.

Candidates must note that their candidature is purely provisional and is subject to being declared ‘Eligible’ during verification of their original documents at the time of joining at AIIMS Nagpur. In case a candidate fails to submit any requisite documents related to recruitment process of NORCET-08, his/her candidature will be cancelled for the post forthwith. Further, if at any stage it is found that the selected candidate does not fulfill any of the eligibility criteria or if he/she concealed or given incorrect information which if known earlier, would have rendered him/her ineligible for selection, his/her selection/appointment to the post will be cancelled forthwith at any stage without assigning any reason.
