A call for Scientist positions announced for a research project titled “*Strengthening ambulatory care for Non-Communicable Disease (STAR NCD)*”: An Implementation Research” funded by Indian Council of Medical Research (ICMR) under Dr. S. Kalaiselvi (PI) & Dr. Sujiv Akkilagunta (Co-PI).

The total duration of the post is for 11 months initially, extended maximum up to the end project date (30th March 2027) depending upon the project requirement and performance.

Selected candidates are expected to work at Nagpur district.

However, candidates with higher qualifications also can apply. #The age relaxation for SC/ST candidates is up to a maximum period of 5(Five) years and for OBC candidate up to a maximum period of 3(Three) years. Age relaxation up to 5 years may be granted to deserving candidates having experience of working in Government Research Organization on a case-to-case basis, by DG, ICMR/Head of the Institution

Duration of first appointment will be for 11 months. The contract will be renewed based on the performance evaluation by the project investigator with the approval of the Director. In case, the candidate is not performing well the candidate can be terminated with a notice of one week.

Terms & conditions:

1. This post is a tenure job for fixed duration under ICMR funded research project.
2. These are not the regular posts under ICMR or AIIMS Nagpur.
3. Based on this experience, the selected candidate cannot claim any permanent employment either from ICMR or from AIIMS Nagpur.
4. In case the candidate wishes to resign from the post, he/she should furnish a notice of 30 days' period.
5. Once the project duration is completed, the tenure is automatically over for candidate selected for this project
6. The candidate should be able to talk fluently in English, Marathi and Hindi
7. No TA/DA will be provided for attending the interview
8. Apart from the consolidated mentioned salary per month including HRA and travel claims the candidate is not admissible for any other allowances.
